

Projected Revenue by Fund Source




This chart shows the total general purpose revenue Bogus Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Bogus Elementary School District is \$432,563, of which \$243,159 is Local Control Funding Formula (LCFF), \$99,175 is other state funds,

\$\$48,904 is local funds, and \$\$41,325 is federal funds. Of the \$\$243,159 in LCFF Funds, \$\$44,499 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

General fund expenditures not included in the LCAP are used for general operating costs such as salaries and benefits, utilities, transportation, supplies, and food services.


Increased or Improved Services for High Needs Students in the LCAP for the 2022-23 School Year

In 2022-23, Bogus Elementary School District is projecting it will receive \$44,499 based on the enrollment of foster youth, English learner, and low-income students. Bogus Elementary School District must describe how it intends to increase or improve services for high needs students in the LCAP. Bogus Elementary School District plans to spend \$33,030 towards meeting this requirement, as described in the LCAP.

Staff provides individualized education plans and small groups for our high needs students, as well as additional tutoring time throughout the day. We also provide academic support during our after school program. We also provide volunteer time for working in outdoor science activities.

Bogus Elementary engaged our educational partners during board meetings to plan the use of funds provided through the Budget Act of 2021. Through those discussions it was decided to use the Educator Effectiveness grant to get staff more training in common core math and to assist the acting superintendent with her mentorship program after she finishes her administration degree. The Expanded Learning Opportunities Program funds will be used to partner with Montague Elementary for a summer program as well as put on a science camp at Bogus Elementary over the summer. Concentration Grant Funds will be used to retain current staff.

The additional concentration grand funds were not sufficient to increase the number of staff therefore we used the funds to retain staff that provided extra tutor time with unduplicated students who are low-income, English learners and/pr foster youth.

A description of how and when the LEA engaged its educational partners on the use of one-time federal funds received that are intended to support recovery from the COVID-19 pandemic and the impacts of distance learning on pupils.

Bogus Elementary School sent out a survey to parents and guardians asking for interest in a two week summer learning session as well as what they would most like to be taught during our summer session. The results were 50% of responses would send their student to a summer session, 33% responded no, and 16% were undecided. After finding there was an interest, all teachers and aides discussed the best use for the summer session. Teachers were asked to analyze students STAR test scores, grades, and percent of curriculum completed. Once looking at the data, the LEA discovers that 100% of the reading curriculum and 92% of the math curriculum was/ would be covered before the end of the school year, however only 37% of the science curriculum has been covered. The drastic difference was due to the focus on math and reading during distance learning times. The teachers and aides decided it be best to cover science in the summer session. The school then contacted interested parents to get their input on the science themed summer session. The response was very positive with all families who were originally interested, remaining interested. Teachers wanted to name the summer session something that would interest students as well as parents. The name 'Science Bootcamp' was settled on.

Plan Summary [2022-23]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Bogus Elementary School was established in 1872 and, except for a brief time, has been open since. We are located in the far northern part of the state near Copco Lake in a remote rural farm area in Siskiyou County--one of the largest counties in California, with one of the smallest populations.

The county is described as frontier, with less than 11 persons per square mile, and has no census defined place within the area with a population exceeding 50,000.

The county's 25 school districts are small and serve approximately 5,871 students. With over 6,000 square miles in the county many districts, such as ours, are remotely located in very small communities with very limited resources.

There are currently 15 students at Bogus Elementary, with 1 English Language Learner student.

Foster subgroups vary in number but are never over 2 families.

Special education subgroups vary in number and can range from 1 to 4.

Approximately 85% of our students are low-income.

Bogus Elementary has 1 teacher/principal and 1 aide to serve our students. In addition to our regular core program, we offer an amazing music program which includes Native American flute, guitar, and piano. A special education teacher and speech therapist services are provided weekly through the County Office of Education. Science has become a big focus for our school in recent years. We purchased a new curriculum and partner with the Outdoor Science Program offered through the County Schools office. We offer the Siskiyou After school For Everyone (S.A.F.E.) program which is tied into our regular curriculum to extend and enrich learning. We focus on hands-on experiences in the after school program. We also offer our facilities to older students, that have already graduated from Bogus Elementary and have chosen to home-school for their high school years, so they can continue their studies online within an educational environment.

Reflections: Successes

One success our LEA had this year was to meet the one-to-one technology goal set. We also updated older chromebook models so all students had the same version of chromebook. To maintain this progress, we will continue to update devices as needed. We purchased a new science curriculum that meets the NGSS standards.

Reflections: Identified Need

We need to implement the new curriculum with fidelity to ensure students are learning and retaining information. ELA is another area of concern for our students, so identifying low performing students and providing them with the tools they need to succeed will be a priority.

Stakeholders include parents, board members, students, community members, and staff. Parents/ Guardians and students are surveyed annually. The survey's purpose is to receive feedback on the current school year as well as get input for the coming year. 80% of parents returned the survey and of that 100% of parents stated that: "the school provided information and training that helps me support my child's learning"; "The school does a good job of getting important school and classroom information to parents"; and "I am provided opportunities to be involved in my child's education." Board members and community partners have the opportunity at every board meeting to add their input for the LCAP. The SELPA is consulted at the annual LCAP meeting. Staff members attend a meeting the first Friday of every month to provide feedback and help guide the goals of the school. We have no bargaining units at Bogus Elementary and no EL students.

Due to the positive response in the parent survey, the LEA will continue its Newsletter, Parent Volunteer program, and all existing stakeholder engagement opportunities. Board Members have express interest in both keeping up to date with current curriculums as well as adding to the school grounds, for example, new playground and solar panels. We prioritized curriculum for the next school years big purchase and will set aside money to save up for the solar panels.

Purchasing a new NGSS aligned science curriculum will be the number one priority for the LCAP as we can tie that in with a summer school program to make it more a of science camp instead of just summer school. As for the school ground improvements we will be setting aside money each year to save up for those larger purchases.

An explanation of why the LEA has developed this goal.

In the 2018/2019 CAASPP ELA test, only 28.57% of students 3-8th grade scored 'exceed or met standard'. In math, the same group of students scored 21.43% 'exceed or met' standards. In science, 0% of students scored 'exceed or met'. After reviewing the results, our LEA decided that purchasing curriculums that aligned with CA state standards was a top priority. When the LEA completed Priority 2 self-assessment tool on Dashboard, we did not meet the standards for 'fully implemented' in Science and Social Studies. These two factors combined guided the LEA's decision to make sure students had access to quality curriculum that aligns with state standards.

Based on 2019 CAASPP scores, 29% of student exceeded or met standards in ELA, 21% exceeded or met standards in math and 0% exceed or met in science, the LEA decided to increase and improve services for low performing foster youth, English learners, and low-income students. In order to meet these students needs, the LEA retains staff (action 1.9) and provides an extra aide (action1.2) and tutoring time (actions 1.7 & 1.10) to help students who are struggling in certain content areas. The LEA also provides standardized assessments so students can track their improvements throughout the year (action 1.8).

The attendance rate for 21-22 is 87.8% and the chronic absenteeism rate is 18.75%. To help address these needs, we are providing actions 2.1, 2.2, 2.5, 2.7, and 2.8 which include volunteers and parent participation to help support enhanced learning opportunities such as Science Days, as well as enhanced attendance monitoring and administrative support.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

In addition to the above actions, the LEA also provides an after school program. This after school program helps students with homework, making up any missed work, and additional tutoring time for 3.5 hours.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

Bogus is a single-school district with only 2 employees. The additional concentration grant funding is not sufficient to increase staffing and will be used in action 1.9 to retain staff.

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action[s])

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
